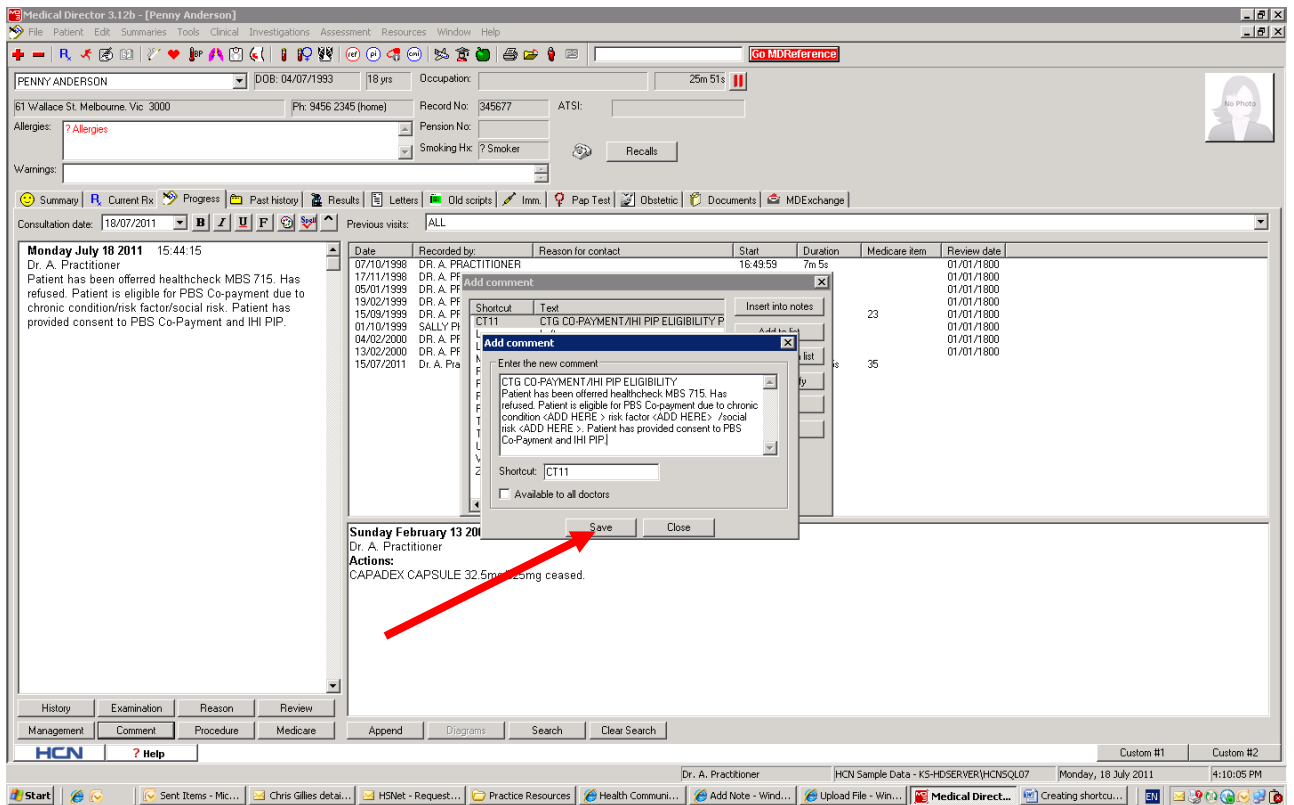

3. Insert text to appear when you select this code. This should be an easily edited text applicable to most patients and click 'SAVE'. For example:
